Terms and Conditions:

- Memberships may be placed on hold for a minimum of two (2) months and a maximum of five (5) consecutive months within a one-year period.
- Hold dates must be determined in advance.
- A fee of \$5.00 must be paid to initiate the hold. For each month the membership is on hold, an additional \$10.00 maintenance fee (full fee memberships) or \$5.00 maintenance fee (scholarship memberships) will be drafted on the fifth (5th) business day of the month from the bank/ credit card account on file and currently used to fulfill your membership dues obligations. The monthly maintenance fee does not apply to Fitness Passport, Silver & Fit or SilverSneakers memberships.
- Monthly Locker Rental debits cannot be placed on hold. You can either continue your Monthly Locker Rental debit, thus retaining the locker for use upon your return (you will not have access to the locker while your membership is on hold), or you can cancel your Monthly Locker Rental debit in accordance with the cancellation policy.
- While the membership is on hold all Parking Card debits associated with the membership will be suspended and use of YWCA Minneapolis parking lots will be prohibited.
- While the membership is on hold all members on the account will be denied access to all facilities.
- Upon completion of the hold draft deductions will return to the current monthly rate, including any Parking Card debits associated with the membership.
- In the event a bank or credit card draft is not honored by your financial institution, YWCA Minneapolis will continue withdrawal attempts through the duration of the hold. If those attempts prove unsuccessful, YWCA Minneapolis will draft any outstanding balance with the first regular membership dues deduction.
- Memberships on hold cannot be canceled. All membership cancellations are subject to the cancellation policy.
- Scholarship memberships cannot be placed on hold for more months than remain in the membership term.
- Short-Term or automatic 12-month self-renewing memberships cannot be placed on hold.
- Placing a membership on hold will not extend locker or service expiration dates.
