HEALTH & WELLNESS - Three urban Minneapolis locations provide access to quality facilities, classes and fitness professionals to 25,000+ members. A welcoming, inclusive environment supports the participation of people across cultures, income levels and age. HEALTH & FITNESS SCHOLARSHIPS: The YWCA makes fitness accessible by offering fee-based scholarships to youth, adults, and families who cannot afford the full cost of a membership. Youth in the YWCA Girls & Youth programs and some families using YWCA Children's Centers receive scholarships. In 2015-16, over 3,900 people were awarded support for their health & fitness membership. WOMEN-CENTRIC PROGRAMS: In 2015-16, over 1,800 women participated in classes, workshops, leagues and races. Women's basketball league had nearly 60 teams with 34% of players age 40 and up. Nearly 1,200 female triathletes, ages 11 to 78, registered for the 8th annual YWCA Women's Triathlon. SWIM FOR CHANGE addresses the fact that in Hennepin County people of color are nearly twice as likely to drown as white people, with those most likely to drown children under age 14. To change this, children and youth involved in YWCA Early Childhood Education and Girls & Youth programs have access to swimming lessons. In 2015-16, 314 young people ages 4-18 participated in swimming lessons, most were children or youth of color. (25,367 fitness members)

EARLY CHILDHOOD EDUCATION (ECE) - High-quality nationally accredited early childhood education was provided at six YWCA Children's Centers across the Twin Cities. In 2015-16, 771 children ages 6 weeks to 10 years old were served. Four community focused Centers served 525 children, 73% children of color, 66% lived in low-income households with 61% living in households at or below poverty level, and 50% from single parent households - primarily led by mothers. Experienced professional teachers partner with families to prepare children to excel in school and life. Unique play-based YWCA ECE curriculum incorporates anti-bias values and conflict resolution skills. Learning opportunities incorporated into every part of the day promote social and emotional development, language and literacy development, creativity and the arts, cognitive development, physical and motor skills. Four bungalows at YWCA Abbott Northwestern Center provided job-training opportunities for New American childcare providers working towards their Childcare Development Associate credential. Care was provided in Somali and Spanish in rooms that also incorporated cultural elements. OUTSTANDING EDUCATIONAL OUTCOMES: For children in care for 6+ months: 94% of children demonstrated age appropriate developmental progress; and 94% of preschoolers met rigorous early learning standards indicating school readiness. (771 children)

GIRLS & YOUTH - Five YWCA out-of-school programs prepare Minneapolis youth to be learners, leaders and creators of change so they graduate from high school ready for college and career. Culturally responsive high-quality programs use research-based curriculum focused on academic success, positive social/emotional development, leadership skills and physical health. In 2015-16, 1411 youth were served in core programs at 18 Minneapolis public schools and two YWCA locations - 93% lived in low-income households, 95% youth of color, 65% girls. An additional 442 youth attended workshops and outreach activities. PROVEN RESULTS: 90% of youth demonstrated social/emotion skills in positive peer relationships and 91% in self-management; 87% demonstrated a connection to learning and school; 97% stated it was important to them to graduate high school and 95% intend to pursue post-secondary education. GIRLS INC. AT YWCA MINNEAPOLIS: Through girl specific leadership development, STEM education, financial literacy, and pregnancy and violence prevention, more than 500 girls were inspired to become strong, smart and bold. (1,853 youth)

For any amendment which would alter the Bylaws in such a way as to affect the YWCA's affiliation with the YWCA USA, the required procedures for general amendment must be met; and, in addition, the amendment must be adopted by a two-thirds affirmative vote of the voting members present at two subsequent meetings of the membership.

Form 990, Part VI, Section B, Line 11b - The Form 990 is first prepared and reviewed by Business Office staff, who review and confirm all facts and figures. Subsequent to the staff review, Form 990 is provided to the Finance and Audit Committee. The Finance and Audit Committee reviews and approves the content of the Form 990 at their November meeting, who then recommend the approval of the Form to the full Board at a subsequent full Board meeting. Upon the Board approval, Form 990 is filed with the IRS.

Form 990, Part VI, Section B, Line 12c - Board Members are required to complete disclosures of potential conflicts of interest upon being elected and annually. The Senior Leadership Team is also required to disclose potential conflicts of interest annually. The CFO reviews these disclosures and advises the CEO and the Board Chair of potential conflicts of interest. In matters where a potential conflict of interest exists, the Board is notified and the individual with the conflict of interest is recused from deliberations or voting on those matters.

Form 990, Part VI, Section B, Line 15 - The CEO's performance is reviewed and compensation is set annually by the Board of Directors. The CEO prepares a self-assessment including performance to annual goals. The Board Chair meets with the CEO's direct reports and solicits evaluations from all Board Members, summarizes all comments and prepares a confidential report to the Board. The Board Chair leads a discussion with the Board Members on the CEO's performance rating, performance feedback and any proposed compensation action with no staff or CEO present for the discussion. Before compensation is set, a survey of compensation of comparable organizations and positions is reviewed. The Board Chair and CEO meet to discuss the performance review and compensation actions, if any, are provided to Human Resources for action.

In 2015-16, 4,100+ diverse individuals were empowered to take action to eliminate racism through public forums, community dialogues, workshops and trainings, focused on promoting open communication, raising awareness and motivating people to take action to improve racial equity in their local communities and Minnesota. Creating space for meaningful and open dialogue about racism and privilege is the critical first step to building a just and inclusive community. Organizations across the nonprofit, education, corporate and government sectors engaged in customized solutions around the challenging issues of race, diversity and inclusion and 340 facilitators were trained to lead productive conversations about race relations and equity. For more than a decade, the YWCA has brought together courageous community leaders and members - to talk, to listen, and to disagree - in their shared commitment to improve racial equity. In November 2015, 1,300+ people attended the 13th annual It's Time to Talk: Forums on Race. PUBLIC POLICY - YWCA Minneapolis believes every person has a role to play in shaping public policy.
