HEALTH & WELLNESS: Three Minneapolis locations provided state-of-the-art fitness facilities, swimming pools, group fitness classes and fitness coaching for 27,000+ members in 2018-19. A welcoming, inclusive environment supports the participation of people across cultures, income levels and age. HEALTH & FITNESS SCHOLARSHIPS: YWCA Minneapolis makes fitness accessible by offering fee-based scholarships to youth, adults and families who cannot afford the full cost of a membership. In 2018-19, over 3,500 people were awarded support for their health and fitness membership. In August 2018, approximately 1,400 women and girls, ages 11-80, competed in the 11th annual YWCA Women's Triathlon - celebrating the strength in all women.

EARLY CHILDHOOD EDUCATION (ECE): High-quality nationally accredited Early Childhood Education was provided at five YWCA Children's Centers across the Twin Cities. In 2018-19, 716 children ages six weeks to 12 years old were served. Four community-focused centers served 564 children, 73 percent children of color, 64 percent living in low-income households at or below 200 percent of federal poverty guidelines and 56 percent from single parent households. Experienced professional teachers partnered with families to prepare children to excel in school and life. Our unique play-based, anti-bias curriculum incorporates values of diversity and conflict resolution skills. Learning opportunities incorporated into every part of the day promote social and emotional development, language and literacy development, creativity and the arts, cognitive development, and physical and motor skills. OUTSTANDING EDUCATIONAL OUTCOMES: For children in care for six or more months in 2018-19: 94 percent of children demonstrated age-appropriate developmental progress, and 90 percent of preschoolers met rigorous early learning standards indicating school readiness. EARLY CHILDHOOD EDUCATION WORKFORCE DEVELOPMENT: This program provides access to comprehensive training and support for participants to complete a Child Development Associate (CDA) - a

GIRLS & YOUTH: Five YWCA Minneapolis out-of-school-time and summer programs prepare Minneapolis youth to be learners, leaders and creators of change so they graduate from high school ready for college and careers. Culturally responsive high-quality programs use research-based curriculum focused on academic success, positive social/emotional development, leadership skills and physical health. In 2018-19, 1,200+ youth were served in afterschool programs at 16+ Minneapolis public and charter schools and two YWCA locations - 91 percent lived in low-income households, 96 percent were youth of color and 66 percent were girls. PROVEN RESULTS: In 2018-19, 83 percent of youth demonstrated social/emotional skills in positive peer relationships and self-management; 78 percent demonstrated a connection to learning and school; 96 percent stated their intention to graduate high school and 93 percent intend to pursue post-secondary education.
